

Terms and Conditions of the Website timexsa.pl

§1 Definitions

1. Service – the website available at <https://timexsa.pl/>
2. Administrator – TIMEX S.A. with its registered office in Warsaw, ul. Bonifraterska 17, 00-203 Warsaw, e-mail: info@timexsa.pl.
3. User – any person using the Service.
4. Personal data – information about an identified or identifiable natural person (e.g., first name, last name, e-mail address, phone number).
5. Contact form – a form made available in the Service enabling the sending of an inquiry.
6. Cookies – IT data stored on the end device of the Service User (e.g., cookies), used in accordance with the presented rules.

§2 General provisions

1. Use of the Service is voluntary and constitutes acceptance of the provisions of these Terms and Conditions.
2. The Terms and Conditions define the rules of using the Service, including rules related to content sharing, personal data processing, and the use of cookies.
3. Use of the Service requires access to the Internet and a device with a web browser.

§3 Rules of use

1. The User undertakes to use the Service in accordance with the law, these Terms and Conditions, and good practices.
2. The User may not take actions that could disrupt the functioning of the Service, in particular interfere with the website code or place malicious content.

§4 Content and copyright

1. All content available in the Service (texts, graphics, photos, website layout) constitutes the property of the Administrator or third parties who have granted a license for their use.
2. The User may use the content of the Service solely for their own informational purposes.
3. Reproduction, distribution, or use of the content without the Administrator's consent is prohibited and may infringe copyright.

§5 Contact form

2. Data provided in the form is processed in accordance with the Privacy Policy, which is an integral part of these Terms and Conditions.
3. Providing data via the form is voluntary but necessary to process the inquiry.

§6 Limitation of liability

1. The Administrator makes efforts to ensure that the information available in the Service is up to date and reliable; however, they are not responsible for its completeness and timeliness.
2. The Administrator shall not be liable for damages resulting from the use or inability to use the Service, in particular for data lost or damaged as a result of technical errors.
3. The Administrator is not responsible for content on external websites to which links may lead from the Service.

§7 Personal data protection

1. The Administrator processes Users' personal data in accordance with applicable law, in particular the GDPR.
2. The rules of personal data processing, purposes, recipients of data, and the rights of data subjects are defined in the Privacy Policy available in the Service.
3. The User has the right to access their data, rectify it, erase it, restrict processing, transfer data, object, and lodge a complaint with the President of the Personal Data Protection Office.

§8 Cookies

The Service uses cookies for the purpose of:

- a. proper functioning of the Service (technical cookies),
- b. adjusting content to the User's preferences,
- c. keeping anonymous visit statistics,
- d. analyzing the effectiveness of marketing campaigns, if the User has given consent.

Detailed rules regarding cookies and the method of disabling them are included in the Cookie Policy.

Use of the Service constitutes consent to the use of cookies in accordance with browser settings or consent tools.
